

Fayetteville Area Shag Association
Membership Meeting Minutes
February 13, 2023

The February 14, 2023 regular FASA meeting was called to order by President Kathi Baloyot.

The Minutes of the March meeting that were emailed and posted on the FASA website we approved.

Committee reports:

- A. DJ's – Beverly Hobgood – Ashley Holland will play February 25
- B. Hospitality – Vacant
- C. Membership – Dwight Vinson – We have 40 members including Past Presidents. If a Past President does not attend a FASA function in 2 years, that person goes to the inactive list. We currently have 12 active Past Presidents.
- D. Phone Tree – Dwayne Baggett – Nothing to report
- E. Publicity / Website – Kathi Baloyot – The FASA Facebook page is active again. Please "Follow" the page.
- F. SOS – Steve Miller – Not present

Old Business:

- A. The 2023 Budget was discussed again, voted on and approved.
- B. A new Profit and Loss Statement for 2023 was explained.
- C. A new party event, a drawing to "Win a Free Pass" was explained. The names of FASA members present at the party are put in a pot. A name is drawn and that member wins a free pass to a 2023 FASA Party not including December.
- D. Another new party event, "\$2 for the Money" was explained. All current FASA member's names are put in a pot. Those FASA members who are present at the party are eligible to register to play the game by paying \$2. One name is drawn from the pot. If that FASA member is present and has registered to play they win the pot. If no one wins the pot, the money rolls over to the next party.

New Business:

- A. Peggy Perry and Beverly Hobgood attended the Association of Carolina Shag Clubs (ACSC)/Society of Stranders (SOS) Winter Workshop Meeting. Peggy reported that Dwayne Baggett, Susan Harrell and Ronnie Gregory were re-elected to the SOS Board of

Directors. Clubs were told that there is no guarantee that money will be returned at the end of the year from the ACSC Board.

- B. Kathi Baloyot told us to look for the new FASA Facebook page. Beverly Hobgood volunteered to be the co-administrator of the page along with Kathi.
- C. There will be a change in the party dates. Most parties will now be held on the 3rd Saturday of each month due to conflicts. Each date is posted on the FASA website, FASA Facebook page and in the monthly news emailed to each member. FASA members have volunteered to host all parties except one, which will be a Potluck in July. A Party Planning Sheet was provided to all hosts/hostesses for guidance.
- D. A discussion concerning eliminating the privilege that Past Presidents don't pay dues and were considered Lifetime Members was held. Rachel Dixon made a motion that beginning in 2023, sitting Presidents will not have to pay annual dues the year that they serve. Past Presidents are no longer considered Lifetime Members. They will pay dues to maintain membership. The motion was discussed, voted on and passed.
