

**Fayetteville Area Shag Association**  
**Monthly Membership Meeting Minutes**  
**November 14, 2023**

The Monthly Membership Meeting of the Fayetteville Area Shag Association was called to order by Vice-President Dwayne Baggett at 6:40 pm. President Beverly Hobgood was not present as she was out of town on business. Ten (10) members were present.

The Minutes of the October 10, 2023 Monthly Membership Meeting were read by Corresponding Secretary Peggy Perry in the absence of Recording Secretary Sue Fulcher who was not present due to illness.
