

December 13, 2022

The membership meeting was called to order on December 13, 2022 at 6:43 pm at the Elks Lodge by President, Eric Rowe with 17 members present.

Eric opened the meeting with the need of beach T-Shirts so that Sue can get started on the quilt that we plan to raffle off.
